### **5.0 REQUIRED DOCUMENTS**

- 5.1 Passport copies of applicant.
- 5.2 Copy of the birth certificate.

- 5.4 Copy of resident visa for non-nationals.

### **6.0 PROCEDURE FOR SUBMISSION**

- 6.1 Duly completed application to be submitted by the Proposer to the Member Relations Executive during office hours, Monday to Saturday.
- 6.2 On receipt of a perfected application the Member Relations Executive will issue a note confirming receipt by the Club of the application.
- 6.3 Applications that are incomplete shall be returned to the Proposer for resubmission with the required information / documents.
- 6.4 Submission of an application does not guarantee membership nor a call for an interview.
- 6.5 The CSC as a matter of practice does not officially comment on and /or correspond regarding the status of any pending membership applications. Any inquiries regarding the status of applications is discouraged and canvassing in any form will be a disadvantage to the applicant.

### **7.0 CHARGES**

#### **7.1 Joining Fees**

Entrance fees paid shall not be refundable.

- Age shall be calculated to the last day of the following month of the date of payment of membership fees. Dependent children aged 21 to 24 years should necessarily be following full time studies with documentary proof to be submitted annually for approval of the General Committee. If student proof is not submitted dependent child will cease to be a member of the club and a separate application will have to be submitted as a new member.
- Member seeking own individual membership at current discounted rates, must have been a child member of age 16 years or less at time of joining under family membership.
- Granting of individual membership to dependent children will be considered only on attaining age of 21 years.

#### **7.2 Refundable Deposit**

The successful applicant will have to bear the refundable deposit of **Rs. 250,000.00** at the time of acquiring membership.

**7.3 Annual Subscription**

Primary Member : Rs. 30,500

**7.4 Cover Charge**

Cover Charge payable quarterly is charged when a member does not utilize Food & Beverage beyond Rs.7,500/= per quarter. Amount payable is calculated as the difference between Rs. 7,500/- and the amount utilized for food and beverage during the quarter. Calculation of cover charge will be independent for each quarter.
