8.0 PROCEDURE FOR SUBMISSION

- 8.1 The duly completed application shall be submitted in person by the applicant to the CSC Membership Office during weekdays, excluding mercantile holidays, between 8:30 a.m. and 5:00 p.m., and all original documents shall be produced for verification at the time of submission.
- 8.2 On receipt of a perfected application the Member Relations Executive will issue a note confirming receipt by the Club of the application.
- 8.3 Applications that are incomplete shall be returned immediately for resubmission with the required information / documents.
- 8.4 Submission of an application does not guarantee membership.
- 8.5 The CSC as a matter of practice does not officially comment on and /or correspond regarding the status of any pending membership applications. Any inquiries regarding the status of applications is discouraged and canvassing in any form will be a disadvantage to the applicant.
